## SITE ALLOWANCES

## FROM 1 OCTOBER 2018

The CFMEU Pattern EBA 2016-2018 states that when Site Allowance is payable, it will be in lieu of confined space, wet work, dirty work, second-hand timber and fumes (Appendix C - 5). In accordance with the Agreement other special rates and disability payments (other than those listed above) may also be payable, in addition to Site Allowance. On sites where no Site Allowance applies, Award Special Rates for work in confined spaces, wet work, dirty work, second hand timbers and fumes may still be payable.

Effective from 1 October 2018, Site Allowances and Project Values in Appendix C will be adjusted in accordance with the CPI movement (2.3\%). Site Allowance has been adjusted up or down to the nearest 5 cents and Project Value to the nearest $\$ 100,000$. As of the 1 October 2018 the new rates and values are:

Minimum Project Value - \$3M below which no Site Allowance is payable (Appendix C - 7(a)).
