Allocation Amounts*

Subsidy applications received in the financial year period will be subject to an allocated amount. Allocations start at \$1,250 and are subject to increase based on the Membership Category you hold with Master Builders. Contact the Training Institute for more information.

- A maximum subsidy payment of \$1,000 per individual, per course is available upon proof of successful completion each financial year.
- This will be dependent on the amount of available funds held at the time of the application.
- Once you have checked your eligibility, complete and submit both checklists and the application form on the next page. Your application will be assessed by the Master Builders.
